The New Zealand National Committee (NZNC) of CIGRE welcomes Study Committee B5 (Protection and Automation) to hold its 2017 Annual Meeting and associated Colloquium in Auckland, New Zealand between  $11^{th} - 15^{th}$  September 2017. This is to be held alongside two other collocated events i.e. 2017 CIGRE Asia-Oceania Regional Council (AORC) Technical Meeting and the 2017 administrative meetings of CIGRE AORC and CIGRE Administrative Council.

# The Venue

The Business Conference Centre facility at University of Auckland has been chosen as the venue for both the Study Committee annual meeting and the Colloquium. This venue has very suitable meeting and conference rooms to host business events and very close to high-quality hotel and accommodation options.

### **The Programme**

The program will extend over the whole week. The Study Committee B5 Annual Meeting of Regular Members, Observers, Working Group Convenors will be scheduled at the end of the week following the two-day B5 Colloquium. #### Call for papers

Those wishing to offer a paper as a contribution to the Colloquium addressing one of the Preferential Subjects should initially e-mail a Synopsis of the proposed paper via their CIGRE SC B5 National Committee Member/Observer to reach the Secretary of Study Committee B5 (<u>Rannveig.Loken@statnett.no</u>) before **13 January 2017.** 

In preparing the Synopsis, the author should observe of the following points:

- The Preferential Subject around which the paper will be centred should be clearly indicated;

- The Synopsis should clearly reflect the various points developed in the paper. A Synopsis of at least 500 words is considered adequate and it will be used after the Colloquium on the B5 website (<u>http://www.cigre-b5.org/</u>);

- The full contact details of the main author, including an e-mail address, must be clearly mentioned.

#### Acknowledgement of reception

The Secretary of Study Committee B5 will acknowledge receipt of the synopses before **3rd February 2017**. If no acknowledgement is received, the sender should forward the message once again, to make sure the proposal(s) will be duly considered in the selection process.

#### Submission of full papers

The absolute deadline for the receipt of the full papers is **10 March 2017**. Papers are to be forwarded in electronic format, by e-mail to the Secretary of Study Committee B5 (<u>Rannveig.Loken@statnett.no</u>).

#### **Availability of Papers**

The papers will be made available at the conference website before **15 June 2017** for all people officially registered for the event.

Authors have to be aware that at least one of them has to attend the colloquium and the poster session.

#### **Special reports**

The special reports will be available at the conference website before 15 June 2017.

#### **Discussion contributions**

All prepared contributions including word and PPT files should be sent to SC B5 Secretary and Special Reporter concerned by emails before **1 September 2017.** Contributors will be required to meet with SC Chairman, Special Reporter and SC Secretary in the SR meeting room on **12 September 2017** to review/discuss their contributions and to agree their time slots.

Spontaneous written contributions are also welcomed. Spontaneous oral contributions are accepted at the Chairman's discretion and depending on available time and degree of delegate reaction

#### **The Tutorial**

The tutorial will be held on Wednesday morning, 13 September 2017.

#### **The Poster Session**

The authors are encouraged and given the opportunity to display their work in the poster session in the afternoon of Tuesday, 12 September 2017.

The poster session is an interesting opportunity both for authors and visitors. Authors can present some details of their papers, while visitors can discuss directly with the authors.

Authors can send e-file to Colloquium Secretariat before 13 August 2017 for reviewing if needed, and send the final version before 1 September 2017 for printing by the meeting secretariat or print it by themselves. Dimensions for poster presentation are approximately 100cm x 80 cm. On-site printing service is not available.

#### The Technical Exhibition

In association with the Colloquium, a Technical Exhibition related to protection and automation technology will take place from Monday, 11 September to Thursday, 14 September 2017. Companies will have the opportunity to present their automation and protection products in stands. This is a good occasion for delegates to know directly from the manufacturers, the latest and most modern equipment in the field of protection and substation automation. Please note that the CIGRE Asia-Oceania Regional Council Technical and Administrative meeting attendees from this region will be there during the first half of the week. The Asia-Oceania countries represent a significant growth region in terms of electrical power systems investments.
